RULES REGARDING CHANGE/CORRECTION/ADDITION/DELETION OF NAME/FATHER'S NAME

- 1.(a) When a student wishes to have his/her name as originally entered in the University record changed, he/she shall proceed as under:-
 - i. He/She shall apply to the Controller of Examinations through the principal/University Teaching Department concerned, who originally sent up his/her name, paying the prescribed fee and in case of unregistered and private students(Except Late College Student) by the Chairman of Union Council.
 - ii. He/She shall provide a press cutting of the Notice of change of name/father's name in at least one daily News Paper.
 - iii. He/She shall support his/her application with an affidavit duly sworn before 1st Class Magistrate/Oath Commissioner (by the candidate himself) with signatures of two respectable witnesses thereon.
- (b). When a student wants to get his/her name corrected (including addition alternation or other minor modification not basically affecting the name), he/she shall be required to comply with item No. I (a) (i) above.
